Through these events, and the discussions we had during their course, we successfully recruited a new (very enthusiastic) chair, we circulated a member survey at our largest event to garner more feedback on our communications and event planning for 2017 and 2018. We are also using this information at begin work on a strategic plan with an emphasis on our succession planning. While working on implementing these longer-term goals, we had an incredibly busy, productive, and professionally stimulating 74th year for our medium-small section. We hosted sixteen (!) events this year, including a Science Café Field Trip, a very informative Crafting Beer Event which attracted a diverse audience of chemists and brewers, an expanded Chemistry Day at the Kalamazoo Valley Museum - our 30th (!!) annual event, our 35th year of hosting a series of competitive exams and 43rd scholarship awards to our local chemistry education community, and more. We have made an extra effort this year to document these activities on our website to share with the community and our membership, and you will find this information attached with direct links in each of the pertinent activity reports. You will also find that we diligently report to our membership in our newsletters. A few highlights from our year: We hosted our 35th Annual Chemistry Day at the Kalamazoo Valley Museum, where we added a new forensics event, with an estimated 500 participants. Our 74th year has been one of renewal and increased participation. You will notice a dramatic increase in the number of volunteer event coordinators this year, that we are actively engaging our membership through the events we have chosen to host, and that we have provided a very full event schedule for the resources and budget of a medium-small section. We are working diligently to ensure this momentum carries into 2017 and 2018. We hosted sixteen events this year, five of which were new. Most notable is the incredible longevity of some of these events. We hosted our 43rd Scholarship and Awards Gathering, or 35th Competitive Exam for local high school students. Our largest line-item in our yearly budget
	goes to providing these awards to the outstanding chemistry students and teachers that continue to make this a community where science education is encouraged and pursued.
	We also hosted our 30th Chemistry Day at the Kalamazoo Valley Museum. This year, we added a new forensics activity that was very well received by an estimated 500 attendees (of the 700 who attended the event). This is by far our largest outreach event, with nearly 80 volunteers who provided a wide array of over twenty activities.
	We also hosted our 12th annual CCED events, this year at the Kalamazoo Nature Center and at Celery Flats City Park in Portage, MI. These events draw large local crowds, and our activities were well received both by the children and the adults in attendance.
	We also hosted our sixth-annual ChemLuminary recognized industry-partner program in conjunction with Zoetis. This is our other large event, with over 100 attendees. We took the opportunity to collect survey

results that show we are not over-communicating with membership (a concern of our EC) and that our membership would like us to continue with professional development, outreach, and networking gatherings.
To that end, we had a new industry-partnered event this year in conjunction with ThermoFisher - The Science Behind Crafting Beer. This well attended event was also new for us this year, and garnered a large audience of local chemists, home brewers, and master craftsmen to learn more about the intersection of brewing and analytical chemistry.
We held or sponsored a number of smaller networking events, outreach opportunities, and informative sessions during 2016 which are detailed in our annual report. We have made a large effort this year to communicate this information to our membership in our newsletters, which, we learned through our survey results, are very well received.
Finally, for our local section governance, our EC made a concerted effort to locate a volunteer with the energy and vision to continue to lead our section while we plan for our future and set a plan in place for succession that will secure another active and productive seventy-five years for the KACS. I am thrilled that Steve has stepped-up to lead the section, and I now that it is in good hands.
