11. 2017 Chair's report: Please provide a narrative of the past year's activity/successes/challenges:*

KACS started 2017 with a celebration of our 75th anniversary as a local section. The very well attended event, held at the Kalamazoo Air Zoo, included dinner, recognition of all KACS past chairpersons, an address by ACS ED and CEO Tom Connelly, and a presentation on the SR-71 aircraft.

Up next was successful completion of the 36th annual KACS competitive chemistry exam program for local high school chemistry students, under the leadership of James Kiddle. For 2017 participation involved 387 students, representing 12 area high schools.

Exam winners were feted at our 2017 KACS Awards Ceremony. Along with five local section members achieving 50 year ACS memberships, and our Volunteer-of-the-Year Doug Williams.

For CCED this year, KACS participated in Kalamazoo Earth Day Events. Providing as in previous years under Lydia Hines' leadership, demo/exhibit activities at the Kalamazoo Nature Center and Celery Flats celebrations. In addition this year, KACS sponsored a demo table at the inaugural Kalamazoo Bronson Park ED celebration, and provided an invited speaker for the Kalamazoo March for Science.

KACS participation in Project SEED was revitalized in 2017 under the leadership of Doug Williams. We had one student in the program in 2017, and plans and contacts were made to grow the program going forward.

Over the summer, a group of KACS members put together and submitted an NHCL nomination recognizing the 1950-1990 steroid chemistry work of Kalamazoo scientists at the Upjohn Company. The nomination was well received by the ACS NHCL and PA&PR Committees.

Also over the summer KACS received approval of and implemented an IPG which involved obtaining lab coats prominently labeled with our KACS logo. The lab coats were immediately put to use by KACS members and local chemistry students, providing needed lab personal protection, and providing a mechanism for promoting KACS and instilling a sense of identity for KACS members.

The lab coats also played a big role in a short promotional video KACS produced this year. Steve Seceast set up a video camera on the street in downtown Kalamazoo, and had passers-by celebrate with us the elements of the periodic table. New this year, KACS partnered with the Kalamazoo College Chemistry Department to put on a speed networking event, connecting area university chemistry students with area working-chemist mentors for a night of multiple 1-on-1 career-related, quick networking sessions. About 30 students and 25 KACS member mentors participated in the event, which was very well received, and asked to be repeated in 2018.

KACS threw a student reception in 2017, to thank the local student chapters who provide valuable participation and volunteer service at KACS events. Students who came out for the reception were treated to an opportunity to try curling at the Kalamazoo Curling Club. Also, KACS provided some ACS student memberships, funded by a BTG grant.

KACS celebrated National Chemistry Week in 2017 with our 31st Chem Day at the Museum event. Participating in this event were over 60 volunteers organized by Lydia Hines, who ran chem demos attended by over 1000 kids and parents.

We ended the year with our Recycled Poster Event, held annually at Bells Brewery Backroom. This event continues to be the highlight of Kalamazoo science-related events. The event was awarded this year a Partners for Progress and Prosperity award, honoring this popular collaboration between KACS, Bells Brewery and Zoetis, Inc.

	<p>Additionally, in 2017 we began groundwork exploring development of a KACS strategic plan, aimed at alignment with the ACS 2017 strategic plan. Lydia Hines (Councilor) and Angela Willson (Secretary) were re-elected to the EC, and Bill Schinzer joined as Treasurer. And finally, after recruiting efforts spanning the entire year, Luke Chadwick kindly joined as Chair-Elect for 2018, leaving Steve Seceast and Brian Eklov to repeat as Chair and Immediate Past Chair for 2018.</p>

I know many other local sections are also struggling with this, so we're not alone in this regard. It feels that something major on the national level maybe needs to happen to revitalize the local section concept. But maybe that's just a passing-the-buck reaction due to frustration.
