12. Chair's Report: Please proved a narrative of the past year's activity/successes/challenges *

January through May: The year began with the previously elected chair-elect stepping down due an out of the area job change, so the 2022 Chair continued through the first half of the new year. After years of virtual meetings, we felt we were nearing the light at the end of the Covid tunnel and shook off the shackles of Zoom meetings with our first in-person event in March, cohosted with Kalamazoo College, a virtual visit by ACS President Dr. Judith C. Giordan speaking about science heroes Louis Pasteur and Thomas Edison. In April, the section cohosted Dr. Melanie Cooper's talk, "Transforming STEM Learning Using Theory and Evidence," with Western Michigan University. In May, the section joined the 2023 Tourtellotte Lecture, hosted by Kalamazoo College, for Prof. Renã A. S. Robinson lecture on "High-throughput 'Omics to Advance Equity in Alzheimer's Disease." All these talks were well attended! The section's annual award gathering was held virtually in May, recognizing outstanding college and university students, ACS 50yr and 60yr members, and the section's 2022 Project SEED students. The executive committee was excited to continue making progress on the section's Strategic Plan with four main focuses: Returning to in-person meetings to better connect with our members, resuming in-person community events to better connect science with the general population, growing a new teacher/scientist partnership and mentoring program to better connect our members with the local secondary education community, and expanding the section's Project SEED program to six students (three returning and three new) to support the future of science. June through December: Along these lines we organized a Members' Meeting with Picnic at Oshtemo Township Park on June 24th. The meeting was attended by the entire executive committee as well as students from WMU. During this meeting we learned that students are interested in networking with businesses and employers through KACS. They also desire ways to accrue volunteer hours through outreach opportunities. In June, as a part of project SEED 6 students started their internship training at Kalsec and K College. On July 19th project SEED fellows were treated to an R&D lab tour at Zoetis by Dr. Tomasz Respondek. On August 25th our Project SEED fellows presented their research at the Kalamazoo College Summer Research Symposium. Continuing with our previous efforts Speed Networking is returned for the 7th year on Monday, October 2nd, co-sponsored by Kalamazoo ACS and Kalamazoo College. Attendees included K College chemistry majors, WMU graduate students, and mentors from across Kalamazoo and the Lake Michigan region. This is the fourth virtual networking event, a pandemic induced switch that is helping to grow the event beyond the Kalamazoo/Portage area. Mentors joined us from as far away as Chicago and Mattawan. This year we had robust attendance with 25 students and 11 mentors. We celebrated the Chemistry Day at the Kalamazoo Valley Museum on October 14, 2023. The 2023 NCW topic was Health and Medicine, and the theme is "The Healing Power of Chemistry." This event demonstrated a community-wide collaboration includes chemistry enthusiasts from the Kalamazoo Section of the ACS, Kalamazoo Valley Community College, Western Michigan University, Kalamazoo College, Pfizer, Kalsec, Perrigo and Stryker. We have over 500 participants for this event marking it a grand success event. On October 24, 2023, the Kalamazoo section of the American Chemical Society (KACS) organized it's 11th annual poster session titled "Sustainable Science—Recycle a Poster" at Bell's Eccentric Café in downtown Kalamazoo. The event followed it's usual schedule with a keynote presentation from Kyle Schneider, Ph.D. Dr. Schneider is the Director of R&D at Vestaron in Kalamazoo. The event was made possible due to a generous donation from Zoetis. The event drew close to 100 attendees and 19 poster presenters. In this current year 2023, in cooperation with KRESA, 5 online conference calls with HS teachers, Science Coaches and KACS mentors were organized and were well received. Western Michigan University and K college agreed to have us publicize their lectures to our members. And finally this year we have published and circulated 11 monthly newsletters for our members and community that highlights the current and upcoming events.
